

LIABILITY WAIVER & AGREEMENT

This Liability Waiver & Agreement (hereinafter “Agreement”) is between Helping Animals Live and Overcome, Inc. d/b/a H.A.L.O. No-Kill Rescue (hereinafter “H.A.L.O.”) and pet owner _____ (hereinafter “Owner”), all parties together (hereinafter “Parties”).

The signing of this Agreement is a one-time requirement and shall remain in full force and effect, for an unspecified period of time, with its terms applicable to the Parties each time H.A.L.O. provides services to Owner, to include boarding or training (hereinafter “Service”) for Owner’s pet named _____ (hereinafter “Pet”).

1. Owner agrees to pay the non-refundable rate of Service in effect at the time the Pet is checked into H.A.L.O., with such rate being applicable until the Pet is released from H.A.L.O.’s care.
2. Owner further agrees to pay all costs for special services requested and all veterinary costs for the Pet during the time Pet is in H.A.L.O.’s care. Pet shall not be allowed to leave H.A.L.O. until all fees and costs due are paid to H.A.L.O. by Owner.
3. By signing this Agreement and leaving your Pet in H.A.L.O.’s care, Owner certifies to the accuracy of all information given about the Pet.
4. Owner specifically represents that he or she is the legal Owner of Pet and has the full and absolute right to board Pet.
5. If Owner does not contact H.A.L.O., or pick up their Pet within fourteen (14) days PAST THE SCHEDULED PICK-UP DATE, Pet shall be deemed abandoned, and Owner grants H.A.L.O. the authority to place the Pet for adoption.
6. H.A.L.O. requires Pet vaccination records prior to boarding and training your Pet. If you do not have records available prior to your Pet’s stay, you agree to give permission to H.A.L.O. to retrieve records from Pet’s veterinarian, as listed herein. Owner also gives H.A.L.O. permission to contact Pet’s veterinarian, while Pet is in H.A.L.O.’s care, for any sickness or injury.
7. If Pet becomes ill, or if the state of the Pet’s health otherwise requires professional attention, every reasonable attempt will be made to contact Owner to direct care. However, if Owner is unreachable, H.A.L.O., at its sole discretion, may provide veterinary care or engage the services of a veterinarian of H.A.L.O.’s choosing, with Owner being responsible for all associated fees and costs.
8. H.A.L.O. is not responsible for lost or damaged Pet accessories or possessions belonging to the Pet during their stay at H.A.L.O.

9. Owner understands that despite H.A.L.O.'s best efforts of care and cleanliness, certain communicable diseases, especially but not limited to, upper respiratory illnesses may be unavoidable in any multiple animal facility. Veterinary care, for which Owner shall be responsible, will be sought in the event Pet contracts such an illness.
10. If Pet is showing symptoms of respiratory illness, including kennel cough, or has been diagnosed with upper respiratory disease while in H.A.L.O.'s care, Owner shall be responsible for any care that Pet receives.
11. Owner understands that H.A.L.O. staff are not veterinarians and must follow strict guidelines when administering medications to Pet. Medication will be administered according to the dosage prescribed on the medication bottle and H.A.L.O. staff will not deviate from the prescription. Any medication must be in the original pharmacy container and must have a label with the Owner's name, Pet's name, drug name, dosage, veterinarian's name and date of issue.
12. H.A.L.O. is careful to provide appropriate and adequate supervision for all pets in our care. However, dogs are prone to playing roughly and injuries can occur. Owner acknowledges that certain risks of injury in the boarding and training setting do exist, and Owner agrees to hold H.A.L.O. harmless for any and all injuries resulting from Pet's activities at H.A.L.O.
13. In the event Trainer feels it is necessary to take the Pet home for further training, Owner agrees to hold H.A.L.O. and Trainer harmless for any damage to Owner's home and/or personal property, as well as any injuries to Pet or Owner.
14. If Pet is found to display aggressive action towards another animal or H.A.L.O. staff, Owner accepts responsibility for any veterinary care to other pets and/or medical care to H.A.L.O. staff resulting from Pet's actions. The determination of fault for such actions will be made by H.A.L.O. staff witnessing the event, and their determination is final. Owner further agrees to accept responsibility for any related costs arising from incident, including the cost to repair or replace any property damaged or destroyed by Pet. Owner agrees that should a dispute arise from any action involving Pet, H.A.L.O. reserves the right to release Owner's name, address, phone number, or other pertinent information to those involved, to include but not limited to legal entities, animal control and/or law enforcement.
15. Owner hereby gives absolute right and permission to H.A.L.O. and H.A.L.O. staff, its agents, licensees, successors and assigns to use my likeness or that of my Pet for any purpose whatsoever, including any and all media and related advertising and promotion thereof. I agree that any video recording, picture, or likeness of me or my Pet created by H.A.L.O. is owned by H.A.L.O.

I authorize my Pet to comingle with other animals at H.A.L.O. at the sole discretion of H.A.L.O. staff.

I fully understand and agree to the terms of this Agreement and that such terms will become effective on this _____ day of _____, 20_____.
